ORDER

As per paper read (1) above, the University had invited applications for continuation of provisional affiliation for the academic year 2017-18 from colleges for courses affiliated to this University. The Principal, Mookambika College Of Pharmaceutical Sciences & Research, Mannathur, Ernakulam has submitted application for the continuation of provisional affiliation for the B.Pharm course with an intake of 50 seats vide paper read (2) above.

Pursuant to the application an inspection commission was constituted and the report of the inspection commission submitted vide paper read (3) above was scrutinized by the scrutiny committee. On verifying the inspection report the scrutiny committee, vide paper(4) above observed that Mookambika College Of Pharmaceutical Sciences & Research has all the required facilities like infrastructure, faculty, equipments, library & land and recommended to grant continuation of provisional affiliation to the college for conducting B.Pharm course with an intake of 50 seats for the academic year 2017-18.

The whole matter was placed before the Governing Council and the Governing council vide paper read (7) decided to grant continuation of provisional affiliation for the year 2017-18 to the colleges to which the scrutiny committee has recommended to grant continuation of Provisional affiliation on receipt of the renewal permission from the concerned apex council. Mookambika College Of Pharmaceutical Sciences & Research, Ernakulam comes under the purview of the above said decision. Now the college has submitted renewal permission from the apex council vide paper read (5& 6) above and has also constituted college council.

Sanction, has therefore been accorded by the Hon'ble Vice-Chancellor for implementing the decision of the 39th Governing Council to grant continuation of provisional affiliation to Mookambika College Of Pharmaceutical Sciences & Research, Muvattupuzha, Ernakulam to conduct the following course, subject to the conditions specified below.

- 1 Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- 2 In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 Affiliation granted is strictly provisional and only for the academic year 2017-18. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 4 The College should remit annual administration fee fixed for UG course for the academic year 2017-18
- 5 Admission to the next academic year shall be made only after obtaining prior permission from the University.
